- I. Call to Order, Cindy Brown, Chairperson, at 9:37AM. Cindy asked for introductions from those present.

IV. Perkins Regional grant updates — CTE regional representatives

Cary Stamas (Kent ISD) led a discussion regarding feedback needed as part of the Perkins CLNA comprehensive needs assessment process. Barriers for K-12 students attending CTCs include: the perception of manufacturing; economic disadvantage; race; gender issues (example: females entering traditionally male fields, such as construction); students who fail a class; streamlining options for vocational education; students in foster care; homelessness; location of centers and transportation to centers; employers' awareness of what is legal or illegal when providing work-based learning for students and getting students into their facilities; parental engagement, outreach, and awareness of industries and careers; and the need to outreach to students of color in their communities.

V. Grant Updates

Marshall Plan

Kyle Fiebig (Muskegon Area ISD) – There are 6 Career Readiness Specialists in place, each representing a specific industry. 15 kids per day are being placed in job shadows and internships. The focus is career exploration to lead to a career path.

- VIII. Council Member Activities/Initiatives
 - -Ted Paton (Ionia ISD/Heartlands): Partnering with West Michigan Works! to provide WorkReady curriculum for students. Integrating fire safety; a portable building is being donated to be smokehouse for student and local fire PD training.
 - -Brittany Lenertz (West Michigan Works!): WorkReady (career readiness curriculum) is undergoing 3rd party eval/pilot. For more information, contact Brittany. TalNet is a network of organizations coming together for career development. The focus is how to scale excellent work and best practices. There are 5 projects funded by the DeVos Foundation: Career Coach training/certification; job analysis work to clarify the real requirements of jobs; career readiness expansion; and 2 research projects being done by Talent 2025.
 - -Susan Hatto (Montcalm Community College): Montcalm received a grant to train automation technicians, is running youth summer camps, and is creating curriculum with their mobile trailer (robotics).
 - -Jay Ediger (Junior Achievement): Promoted a staff person to be the Rural Expansion Officer for Region 4 rural areas.
 - -Kristofer Pachla (GVSU): The state adopted computer science standards and has started convening a group to discuss these standards. Those who are interested can join. Interested in highlighted industry industry/education partnerships related to STEAM.
 - -Michael O'Connor: Sec 107 had \$350,000 awarded for Ottawa and Allegan. Classes have started for CNA, EMT, Machine Technician, Welding, and CNC. Childcare and transportation have been identified as barriers; discussing using a van to pick up students to bring them to the tech center and take them back at no cost. Tyson reached out to discuss doing Upward Bound at various locations. Over 200 students expressed interest.
 - -Patricia Walstra (Kent ISD Adult Ed): Throughout Region 4 there are 17 Sec 107 adult education programs at around 80 community locations; many are located at Michigan Works! locations. These are located in Muskegon, Ottawa, Kent, and Osceola counties. IET grants include: Corrections Officer fast track training in Montcalm (Montcalm Community College and West Michigan Works! partnership); CAN training in Muskegon (West Michigan Works! and Muskegon Community College partnership); looking into CDL training in Kent County; and a CNA program in Allegan.
 - -Dave Searles (Ottawa ISD): Switched from Career Cruising to Naviance, and the roll-out went well.

Kyle Fiebig (Muskegon Area ISD CTC): Transitioned to Xello, and it went smoothly.

- -Cary Stamas (Kent ISD): Currently split between Xello and Naviance; have not which one system to use. Tech center is at capacity (22 programs, 2200 students), but have 5-7 initiatives for expanding at other locations.
- -Rey Guzman (LEO): Encouraging Industry-Led Collaboratives and grant funding for this.

-Cindy Brown (The Right Place): West Michigan Works! is undergoing strategic planning with focus groups. Hello West Michigan will host re-think W Michigan, "boomerang" event on Thanksgiving Eve. Plan to outreach to school sports games to reach alumni.

-Amy Lebednick (West Michigan Works!): Going PRO Talent Fund: staff have met with almost 500 employers; about half have started applications. MiCareerQuest planning has begun, and a Project Manager was recently hired to lead the event. Industry council projects include promoting the industry, including parent engagement and training/upskilling the workforce.
