- V. GIS Story Mapping Presentation Diane Miller (MiSTEM Network)

 Diane Miller (MiSTEM) presented on the MiSTEM's efforts developing GIS Story Mapping by cluster and county. Clusters are aligned by STEM-related jobs, certificates, and employment. The goal is connecting STEM-related businesses to student opportunities and career opportunities in the region. VI. CTE Updates (CEPD share-out) – Cary Stamas

- Cary Stamas (Kent) There are 22 state-approved programs at the tech center servicing 2,200 students, with an additional 20 programs at local schools within Kent ISD that service up to 2,800 students. There have been some expansions within their KCTC programming in the health industry: pharmacy, CAN, EMT, medical assisting programs. Work-based learning is being promoted by the state. They plan to return to working on starting a teacher academy. Manufacturing and IT will be expanded as well as part of early middle college programing.
- Dave Searles (Ottawa) revamped many programs within their building, expanding Future Prep program and teacher reach/design thinking, and summer program. COVID has helped us re-look at how we deliver services better and reach more students, in particular our regional programs.

VII. CTE Pathways Grants – Cary Stamas

Focus of this grant is to redefine and emphasis credentials as a core performance indicator. The State of Michigan has put out grant opportunities to have different regions tackle this initiative in consortiums. Kent ISD has taken the lead on a healthcare Career Pathways grant in partnership with West MI Works!, Allegan, Muskegon, and local higher ed (GRCC, Western MI, Muskegon Community College), and healthcare provider employers. The end of the grant process is April 2021. Also brought together a state-wide consortium to look at aviation, including drones.

Brittany Lenertz, Amy Lebednick, and Angie Barksdale shared the following:

- Services
 - Virtual services
 - We have not stopped providing any services to job seekers during the pandemic since we have been able to move to providing virtual services. In addition to regular core services, we are continuing to innovate. Some in-person appointments are being made for things people cannot do from home. Some staff are continuing to help people with unemployment.
 - Youth programming
 We provided in-school and out-of-school summer youth programming virtually
 and are in the process of re-applying for this grant. It will probably be a hybrid
 of virtual career exploration and in-person work experience. We are continuing
 to provide our year-round youth programming virtually.
 - MiCareerQuest

This event will be held virtually on April 21, 2021. Student registration has been extended to allow more time for schools to register. The event can accommodate 30,000 students., however, there are currently only 10,000 students registered. Amy Lebednick asked CEAC members to encourage their schools, teachers, counselors, and principals to go online and register their students. Standards Recognition Entity (SRE)

West Michigan Works! was approved by the USDOL as a Standards Recognition Entity. WMW will work in collaboration with our Industry Talent Councils to approve Industry Recognized Apprenticeship Programs.

- Confirmed Grants
 - Future of Work Grand Challenge This is a national innovative initiative, West MI Works! was one of six entities chosen for the grant. We will be partnered with four solutions providers to develop broadened solutions for how we prepare our workforce development and technical skills. All of the development will be done virtually. We will recruit and enroll local participants to engage in these programs free of charge. It will broaden the way we are preparing our workforce.
 - One Workforce w/ GRCC as Lead applicant
 Awarded \$9.8M with focus on getting talent into the manufacturing industry
 and automation training. This is a 4 year grant.
 - Rural Healthcare w/ State of MI as the lead applicant
 This is a 4 year grant that covers Allegan, Barry, Ionia, and Montcalm counties.
- Potential Grants
 - State Apprenticeship Expansion (SAE) grant
- Job Seeker Survey

This seeks to find out the reason why people are either unable or unwilling to work right now. The survey went out this week to around 10,000 individuals. We hope to not only understand what is going on, but to help ourselves and our employers develop solutions to help people return to work.

• Clean Slate Expungement Pilot

We received funds to help people go through the expungement process. We will hire a navigator and be able to pay legal fees. This will be a practical way of helping people. We will put out an RFP to have attorneys in place to assist people.

Amy Lebednick provided updates on the CEAC Metrics. It was noted that the date for Apprenticeship reporting was listed as 5/20/21. This date is incorrect, the revised date will be reflected in the minutes.

XII. Council Member Activities/Initiatives

- Patricia Walstra (Region 4 Adult Ed): All adult education programs in Region 4 have some sort of distance learning incorporated. Adult education Section 107 RFP is a three year cycle; the new RFP for the next three year cycle has just gone out. Allocations are contingent on funding, which is based on legislature. Special programs grants are still happening, which are at four career tech centers.
